

**TOWN OF SANTA CLAUS PARK & REC BOARD**  
**Monthly Meeting Minutes**  
**June 11, 2021, 4:00 p.m.**

The Santa Claus Park Board met for their monthly meeting on June 11, 2021 at the Santa Claus Community Center at 200 N Holiday Blvd, Santa Claus, IN. The meeting was called to order by President Jonathan Goldsberry at 4:00 pm.

Park Board Member present: Jonathan Goldsberry, Jonathon Kincaid, Eileen Farmer, and Craig Buse.

Also present, Parks and Recreation Director Zach Tischendorf, Santa Claus, and Al Salhoff.

Craig Buse made a motion to approve the May 3, 2021 minutes. Eileen Farmer seconded the motion.

Al Salhoff was present to give an update on the progress of the planned fine art fair. He has established the Santa Claus Art Guild (SCAG), along with a five-person committee to approve entries. He is in the process of developing fliers and posters to aid in advertising. The art fair will be held on October 2, 2021, from 10am-5pm at the Santa Claus Community Center in the grassy area to the front of the building.

Our movies in the park summer series is set to kick off July 3<sup>rd</sup>. Spencer County Bank has committed to sponsor \$300 towards the fees and Kincaid Insurance has committed \$300 to host our first movie. We will need to continue to find sponsors to continue our monthly movies. Each event will cost roughly \$1000.

Santa was present to check on the status of the room rental at SCCC. Director Zach is asking the Town Council to conduct the first and second readings of the amended fees ordinance to establish a monthly rental rate for the medium room at the Town Council Meeting on June 14, 2021, at 5:30 P.M.

Zach Tischendorf will check into replacing the broken treadmill. It should cost less than \$5000 to replace.

Zach will be working with Willowdale on a senior citizen program. SCCC and Yellig park will host senior citizen programs for about an hour once a month. Activities like stretching, walking, bingo, etc. will be hosted. More days a month will be added later.

The board discussed hosting a volunteer day either June 19 or June 26 to sort/clean bottle caps for the Greentree Plastics program.

Craig Buse made a motion to approve the May 2021 Santa Claus Community Center vouchers in the amount of \$3234.10. Eileen Farmer seconded the motion.

Craig Buse made a motion to approve the May 2021 Park and Rec vouchers in the amount \$11384.42. Eileen Farmer seconded the motion.

Jonathon Kincaid made a motion to approve the invoice in the amount of \$2081.00 to Quality Craft for the replacement mulch for the playground, to be paid from the Park & Rec Donation account. Eileen Farmer seconded the motion.


